

AN ORDINANCE PROVIDING FOR THE CONTROL OF  
TRAFFIC ON AIRPORT ROAD IN THE TOWN OF CROSS PLAINS,  
DANE COUNTY, WISCONSIN

WHEREAS, it is deemed expedient and necessary that speed limits be established on parts of Airport Road in the Town of Cross Plains, Dane County, Wisconsin;

AND WHEREAS, it is in the best interests of the Town of Cross Plains that the enforcement of speed limits on part of said Airport Road be provided by the Village of Cross Plains pursuant to intergovernmental cooperation as provided by Section 66.30(3) of the Wisconsin Statutes;

NOW, THEREFORE, THE TOWN BOARD OF THE TOWN OF CROSS PLAINS DO ORDAIN AS FOLLOWS:

Section 1. That the statutory speed limit on the following street or portions thereof as established by Section 346.57(g) are unreasonable, unsafe or imprudent and modifies such speed limit under authority granted by Section 349.11 of the Wisconsin Statutes, as follows:

Speed limits decreased. Speed limits established by Section 346.57(g) are decreased as set forth upon the following streets or portions thereof: 25 m.p.h. on Airport Road from the westerly village limits of the Village of Cross Plains at a point where the westerly line of the plat of Melody Acres is extended southerly to a point on Airport Road where the easterly line of Melody Acres First Addition is extended southerly, it being the intention to include all of Airport Road lying south of and immediately adjacent to the plats of Melody Acres, Melody Acres First Addition, and Melody Acres Second Addition, in the Village of Cross Plains.

Section 2. Authority is hereby given for the Town of Cross Plains to enter into a contract with the Village of Cross Plains for the enforcement of traffic speed on said street pursuant to Section 66.30(2) of the Wisconsin Statutes.

Section 3 - Any forfeitures for violation of this ordinance shall be paid to the Village of Cross Plains as compensation for enforcement.

This ordinance shall take effect after its publication in the Dane County News, Mazomanie Sickle, and Cross Plains Arrow, the official newspaper of the Town of Cross Plains.
